

**CITY OF WALKER
RESOLUTION 18-500**

RESOLUTION ADOPTING A REVISED AND COMPREHENSIVE COMMUNITY DEVELOPMENT DEPARTMENT FEE SCHEDULE AND REPEALING RESOLUTIONS 11-177, 12-226, 12-237, 15-353, 16-387 AND TWO RESOLUTIONS WITHOUT NUMBERS APPROVED IN 2006 WHICH PRESCRIBED CERTAIN BUILDING, PLUMBING, ELECTRICAL, MECHANICAL AND ZONING FEE SCHEDULES.

The Building, Zoning, Electrical, Plumbing and Mechanical Permit Fee Schedules as prescribed under Resolutions 11-177,12-226, 12-237, 15-353,16-387 and two un-numbered Resolutions from 2006 are repealed. The following revised and comprehensive Community Development Department Fee Schedule is hereby adopted, based on the standards of Chapter 18 – Buildings and Building Regulations and Chapter 94 -Zoning of the Walker, Michigan Code of Ordinances.

CH. 18 - BUILDINGS AND BUILDING REGULATIONS PERMIT FEES

The fees for a building permit required by Chapter 18- Buildings and Building Regulations shall be as follows:

1. Detached one and two-family permits shall be sixty dollars (\$60.00) for the first one thousand dollars (\$1,000.00) or part thereof, of the value of the work, plus (\$5.00) for each additional one thousand dollars (\$1,000.00) or fraction thereof.
2. Multi-family, Multiple single family, described in (D) (1), Commercial and Industrial permits shall be sixty dollars (\$60.00) for the first one thousand (\$1,000.00) or fraction thereof of the value of the work, plus six dollars (\$6.00) for each additional one thousand dollars (\$1,000.00) or fraction thereof.
3. No permit shall be issued unless such fee has been paid to the City Treasurer.
4. A plan review fee for all building projects for commercial, industrial, multi-family and for new single-family homes, new condominiums and new duplexes the fees will be as follows:

Commercial -25%	New single-family homes- 15%
Industrial- 25%	New condominiums- 15%
Multi-family - 25%	New duplexes - 15%
5. On any new structure for which a Certificate of Occupancy is required upon completion shall be charged a refundable occupancy permit fee based on the following schedule:

One and two-family dwellings Multi	\$200.00
family structure per building	\$400.00
New commercial and industrial structures	\$500.00

Additions to commercial or industrial structures Renovations	\$300.00
to interior- commercial or industrial structure Swimming	\$200.00
pools	\$100.00

The above fees shall be forfeited if the Occupancy Permit is not issued within 90 days of original written Temporary Occupancy Permit, or if the building is occupied without a final inspection being conducted and an Occupancy Permit written. In the case of multi- family structures the time sequence will be based on the completion of the building.

These fees shall include the following inspections based on the formulated cost of construction:

- 5 (maximum) < \$500,000
 - 8 (maximum) > \$500,000, < \$1,000,000
 - Additional inspection \$50.00
- Projects that exceed \$1,000,000 in construction costs shall have the number of inspections determined by the Walker Building Official.

(These fees will be deducted from your Certificate of Occupancy Deposit. Any fees exceeding the deposit will be billed).

Important Notes: The figures above are not intended to equal actual costs of construction but are used solely as a basis for determining the cost of the construction permit. This shall include single family units when more than 2 are attached together. Remodel/demolition work within an existing structure shall be based on the dollar value and/or the contract price of the work being performed. Sign structures, and any other structure, for which a permit is required, not specified herein shall be based on the total construction cost of such structure.

6. Inspection fees for residential resale per unit and prior to moving a building into the City of Walker:

a. Structural building	\$100.00
b. Electrical	\$100.00
c. Mechanical	\$100.00
d. Plumbing	\$100.00

7. Demolition of buildings:

a. One and two family residential	\$175.00 (per building)
b. Multi-family residential	\$200.00 (per building)
c. Non-residential buildings	\$100.00 (per building)

8. Construction Code administrative, inspection and overtime fees:

a. Failure to gain access	\$40.00
b. Work not ready to be inspected	\$40.00

(The above listed Construction Code administrative fees will be deducted from your Certificate of Occupancy Deposit. If the Certificate of Occupancy deposit is depleted additional fees will be billed.)

Mobile home set-up fee- \$150.00

10. Construction Board of Appeals application - \$250.00

A plan review fee of 15% of the permit fee will be charged for all commercial, industrial, multi-family projects and for single family dwellings over 3,500 square feet.

Expiration of permit: A permit remains valid as long as work is progressing, and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work. A permit will be cancelled when no inspections are requested and conducted within six months of the date of issuance or the date of a previous inspection. Cancelled permits cannot be refunded or reinstated. **NO SERVICE WILL BE CALLED INTO CONSUMERS POWER UNTIL THE INSPECTION FEE IS PAID.**

PLUMBING PERMIT FEES

The fee for a plumbing permit required by the Code adopted per Chapter 18 shall be as follows:

1. No permit for the installation, alteration, or repair of plumbing devices and/or equipment shall be issued until payment shall have been made of the fees set forth to the City Treasurer.

2. To determine plumbing permit fees, the following schedule shall be used:

1. No permit for the installation, alteration, or repair of mechanical or air conditioning devices and/or equipment shall be issued until the following fees have been paid to the City Treasurer.

The fee charge for the holding or a special meeting of the Zoning Board of Appeals is hereby established to be \$350.00 to be paid by the applicant prior to the meeting being called. If more than one applicant requests such a meeting on the same date and item, the fee shall be proportionally shared by all the applicants.


