**Insurance** (the applicant shall obtain comprehensive general liability insurance in amounts of at least \$500,000.00 per occurrence for bodily injury and property damage, and \$1,000,000.00 in the aggregate, with a company authorized to do business in the state. The insurance shall insure the applicant against liability for death or bodily injury to persons or damage to property which may result from the temporary use or conduct incident thereto and shall name the city as an additional insured party. The insurance shall remain in full force and effect in the specified amounts for the duration of the permit. Proof of such insurance shall be furnished to the city prior to the issuance of the permit.

**Fee** - \$250.00(the \$200.00 deposit will be returned once all signs, trash and debris resulting from the temporary use has been removed)

**Firework tents** – please submit the State of Michigan Fireworks Sales Permit

**Signs** – Temporary signs proposed in connection with a temporary use may be allowed in such shape, size, construction, location and duration as approved by the building official in compliance with the provisions of article XIV of this chapter applicable to the zoning district in which the temporary use will be located, provided that where the building official determines that a temporary sign proposed in connection with a temporary use will result in a hazard or nuisance or will otherwise be contrary to the public health, safety or welfare of the community, the building official may impose more restrictive requirements than required by article XIV of this chapter.
