**The following is a list items that need to accompany this application per the City of Walker Ordinance Section 94-522.**

- ❖ Site plan – All Temporary Uses shall be subject to approval of a site plan.
- ❖ Insurance – comprehensive general liability insurance in amounts of at least \$500,000.00 per occurrence for bodily injury and property damage, and \$1,000,000.00 in the aggregate, with a company authorized to do business in the state.(fireworks insurance must comply with the Fireworks Safety Act)
- ❖ A copy of contract or agreement with property owner.
- ❖ \$250.00 fee(the \$200.00 deposit will be returned once all signs, trash and debris resulting from the temporary use has been removed)
- ❖ Copy of State of Michigan fireworks sales permit/Payment of receipt with State of Michigan.
- ❖ "Special Use/24 hr liquor license" must apply with MLCC and clear through the City of Walker Police Department. There will be a fee associated with this application.

**The following is required by the City of Walker Fire Department to be on site for Firework tents and sales:**

- Copy of City of Walker Temporary Use Permit
- Size will determine number of extinguishers on site. A Minimum of 10lb ABC Fire extinguisher.
- Firework tent should be fire retardant and bear the seal of the California State Fire Marshall.
- Copy of State of Michigan fireworks sales permit.

Submission deadline - all applications for a temporary use permit shall be made at least 21 days prior to the proposed commencement date.

Temporary outdoor sales or tent sales by retail merchants is restricted to 14 days in a 12 month period.

Temporary Signs – See Section 94-412 of the City of Walker Ordinances.
