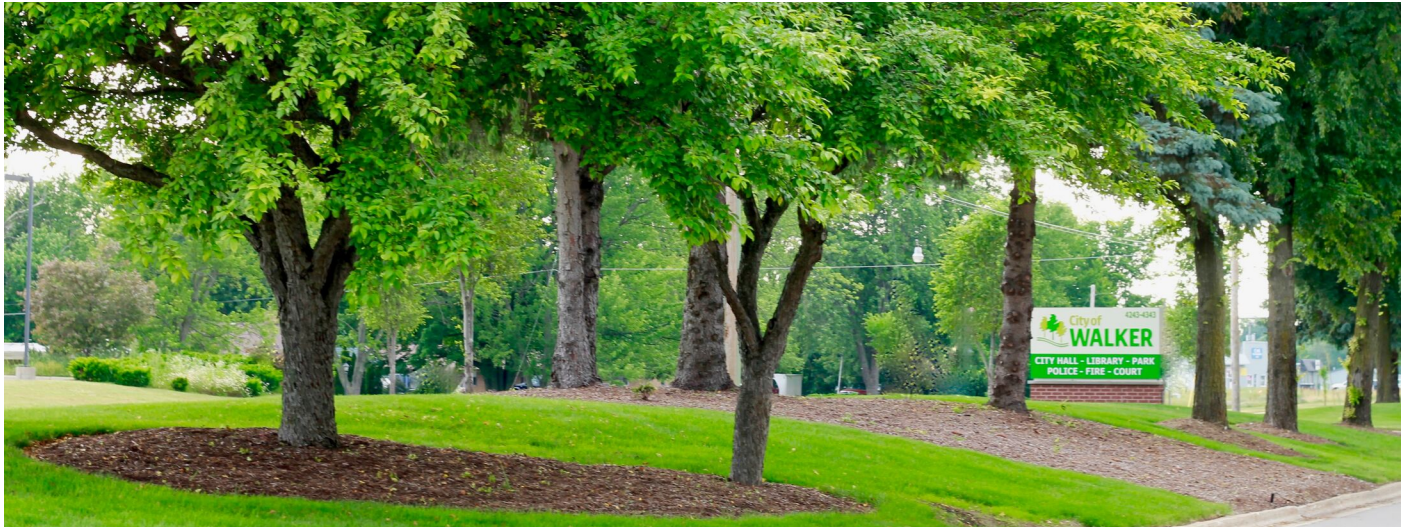

A letter from the Mayor

MAYOR GARY CAREY, JR.

It is my pleasure to share an update from the Mayor's office. Because we do not currently have a State of the City presentation, I will leverage this newsletter to provide a brief overview of a few of our major departments looking into 2019.

On March 4, the City Commission and the City leadership staff will hold our annual strategic planning retreat. In this session we will start with a lookback through the last two fiscal years. During that review we will measure our accomplishments to the goals set, and maybe some that are still in progress. There have been several visible public projects that typically get the publicity and headlines. As equally as important are the behind the scenes actions like succession planning, organizational alignment, transparency and communication, and an aggressive approach to paying down our long-term debt. These will all remain in place this coming year as well as implementing new items identified at the retreat. Look for more to come in this area.

Public safety continues to not only be a focus of our city commission and staff, it is also my top priority as Mayor. *continued on page 2*

That strong sense of security and comfort that we enjoy living and working in Walker is something we can sometimes take for granted. As city leaders we need to always remain vigilant to the current and projected needs of our Police and Fire Departments. As a result, I can now share that our Police Department staffing is finally back to 2005 levels. As a growing city, the need to add officers and vehicles on the street will continue to increase. We have also taken a proactive approach of hiring new officers before our veterans retire. This ensures the knowledge base and training are all done in a timely and most effective manner. With the increased public awareness surrounding mental health issues today, we are also investing in additional training to specifically address the challenges our officers could encounter. Overall, our annual calls for Fire Department service are somewhat flat in most areas, and trending down in others. Knowing the preventative approach taken in stricter fire codes, fireproof building materials, and installation of protective devices like smoke alarms and carbon monoxide detectors, the trend here will probably continue in a favorable manner.

Our Fire Department dedicates a lot of their time within our community educating and assisting with this proactive approach. As far as our staffing, Walker primarily uses a paid-on call model. While this continues to address our current needs, finding candidates has become more difficult. This is a challenge faced by every municipality that uses the paid-on call model. People have more going on in their personal and professional lives than ever before, and the time commitment that comes with the paid-on call role can be challenging. We will continue to develop and refine new ideas of hiring them, while maintaining a focus to our future needs.

This time of year, we are especially reminded that our Department of Public Works continues to set themselves apart with the outstanding jobs they do keeping our roadways plowed and salted for our safe travels. As we enter in to 2019, we are losing two long term employees of almost 67 years of combined service to our city. Their respective roles and leadership have been critical to the day to day operations of helping our city run efficiently. While neither can be measured for their endless dedication serving others, they had the foresight to apply that succession planning concept and have left the City in great shape. In addition to the personnel changes there, it should be noted that in 2018 we invested nearly one million dollars into local roads. This is the highest amount ever and shows our commitment to maintaining a sound infrastructure.

The Ice and Fitness Center celebrated our last bond payment in 2018. This removed our major debt obligation from the original construction of the facility a little over twenty years ago. On the fitness side, we continue to upgrade equipment and invest in new programming. We believe that the amazing experience and service levels that our members have each time they visit will ensure we are positioned to retain our membership and grow. Our hockey operations continue to be one of the best run in the state. The superior quality of coaching and player development is something that I regularly hear within the hockey community. This heavy usage and activity means that equipment related to the operations does require repair and replacement, especially after 20 straight years of usage. Our facility leaders and city managers are already getting ahead of this with responsible budgeting and planning.

In summary, I am very excited about the future of 2019 for City staff, and our residents and businesses. We are in excellent financial shape and continue to invest in many areas, most notably in public safety and roads/infrastructure. This is done with a deliberate intent to address current needs, as well as strategically plan for our future. We will also strive to make 2019 a year that we find ways to make even better the service and experiences you have with the City departments. With all our initiatives and projects, each day is a humbling reminder of what a privilege it is to serve as Mayor of Walker.

Whether a resident or business, thank you for making the choice to call Walker home.

Disposing of expired, unused or unwanted drugs the right way can protect people and the environment. Here is why drug disposal is important:

Drug overdose is the leading cause of accidental death in the U.S. More people die from drug overdoses than car accidents.¹

70,000 children go to the hospital each year for medication errors.² Unused drugs contribute to this.³

69% of people who misused pain medication got them from a friend or relative.⁴

80% of new heroin users began by misusing pain drugs ordered by their doctor.⁵



Meijer Pharmacies will now take your expired or unused medications in a new drug take-back program. Medications can be dropped off in-store during pharmacy hours only.

BURNING PERMIT

By order of the City of Walker Fire Department, an annual burning permit is required for residential burning of branches and small twigs. No other residential or commercial burning is allowed in the City of Walker. **Burning season is April 15 to May 15 and October 15 to November 15 on Mondays, Wednesdays and Saturdays only.** Burn permits will be available online at www.walker.city after April 1, 2019.

SAFELY STORE DRUGS BEFORE DISPOSAL⁶



STEP 1

Keep drugs in the container you received them in.



STEP 2

Lock the container in a cool, dry place out of reach of children and pets.

SAFELY DISPOSE OF DRUGS⁶



OPTION 1: DRUG TAKE BACK

OPTION 2: DISPOSAL RECIPE

If you can't get to a drug take back site, use the recipe below as a last resort to dispose of expired, unused or unwanted drugs.⁵

Disposal Recipe^{5,7}

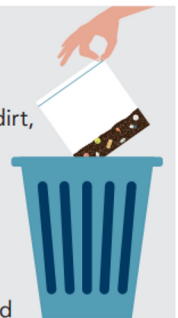
(Do not dispose chemotherapy drugs this way, talk to your prescribing doctor instead.)

Step 1: Mix drugs (do not crush) with dirt, kitty litter or used coffee grounds and add a small amount of water to dissolve any solid medications.

Step 2: Seal drugs in plastic bag.

Step 3: Place plastic bag in trash.

Step 4: Take prescription container and scratch out personal information, then recycle or throw away.



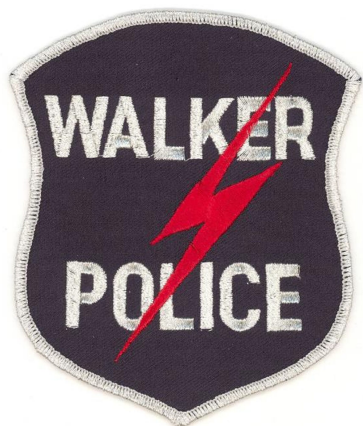

COMMUNITY RESOURCES & HIGHLIGHTS



Walker Police Department responded to just under 13,000 calls for service in 2018, which is average for our city. The department saw Sgt. Rob Shoemaker and Officer Scott Malkewitz retire, as well as Officer Cheryl Leatherman, all who had several years of service and dedication to the City of Walker. The department hired three new officers in 2018, with a fourth set to join the ranks in late January. Officer Matthew Welch was moved into the role of Court Security Officer for 59th District Court, after the retirement of the previous officer.

Walker went through a major cold spell in late January. The cold weather leads many to go outside and start their car in the early morning hours, to warm it up. This serves as a good reminder to keep cars locked when doing so. During this time of year, almost 90% of stolen vehicles are reported to have been left running, with keys in the ignition while warming up. Don't fall into this statistic, and consider the use of automatic starters, or using a spare set of keys to turn on the car, while still being able to lock/unlock the car with the primary set.

Walker Police Department looks forward to continuing our community outreach in 2019. Stay tuned to our Facebook page, "City of Walker Police Department," for updates. We will again be participating in Coffee with a Cop, Pizza with the Police, and Pop with a Cop events throughout the city. If your business is interested in hosting an event, contact our Community Resource Officer at mharkema@walker.city.

Sometime in Mid-March, Walker Police Department, along with Kent County Sheriff's Office, will be conducting a training session for staff at Zinser Elementary. The training will be after school hours, with no students present. It will consist of simulated gunfire, to give the staff a more realistic feel for these types of events. If you live in the area surrounding the school, you may hear or see something that is out of the ordinary. We will alert the nearby residents prior to the training via mail, and the finalized information will also be posted on our Facebook page.

As a reminder, if you need NON-EMERGENCY police assistance, we ask that you call 616-453-5441. If you need general police department information, or need to speak to our records department, you can call 616-791-6812. Please do not depend on messaging our Facebook page for immediate assistance, as it is not monitored 24/7, and your message may not be returned right away. Anonymous crime tips related to Walker Police Department cases can be relayed via Silent Observer.

As always, we appreciate the overwhelming community support for our officers, and look forward to serving you in 2019!

Who must file:

Every resident or part-year resident of Walker (this includes renters) who had taxable income in 2018 of \$600 or more must file a return. More information on taxable income can be found here:

All Walker addresses have Grand Rapids mailing addresses so please do not assume you are not a Walker resident based on your mailing address. If you have past years of Walker returns that you have forgotten to file, contact the tax department immediately at 616-791-6880. If you file prior year returns and pay the tax and interest due, you may request a waiver of penalty. If the tax department contacts you first regarding unfiled returns, you will not be eligible for a waiver of penalty. We are continuing the process of electronically matching state of Michigan returns filed from a Walker resident address with Walker returns filed. If you have forgotten to file Walker returns from prior years, now is the time to get that cleared up before you receive an assessment from this compliance program.

Estimated Payments

The first quarter estimated payment for 2019 Walker Income Tax is also due April 30, 2019.

If your employer does not withhold Walker Income Tax or you have non-wage income (rental income, capital gains, premature pension distributions, etc.) that is subject to tax and you think you may owe more than \$100 with your 2019 return, you must make quarterly estimated payments. The 2019 Quarterly Estimated payment vouchers with instructions can be found:

You must pay in at least 70% of your current or prior year liability (whichever is lower) through timely estimates, credits or withholding to avoid receiving a bill for penalty and interest for underpayment of estimated tax. If you need help calculating safe estimates, please call us for assistance at 616-791-6880.

Please note that paying all four 2019 quarterly estimates with the fourth quarter voucher due January 31, 2019 may result in a bill for penalty and interest for failure to pay timely estimates.

If you use TaxAct software/online tax program to prepare your own federal and state returns, you will be able to e-file your Walker return this year. Please note that other software/online tax programs used for self-prepared returns (TurboTax, H&R Block, TaxSlayer) do not participate with Michigan local e-filing.

UPDATE FROM CITY ENGINEER, SCOTT CONNERS, P.E.



Residents and business owners will see another busy year with improvements and enhancements to the City's road network. 2019 will include adding another left turn lane for eastbound Three Mile Road traffic at Walker Avenue. This enhancement will require extensive widening around the intersection as well as a new traffic signal. Eventually it should help to reduce the length of back ups in front of the Meijer campus as vehicles from the busy Three Mile corridor head towards I-96. The work will take place in the spring and summer. Complete closures should be limited but lane closures are likely to cause back ups during the morning and evening rush hours.

Another big improvement will be the extension of North Ridge Drive between Fruit Ridge Avenue and Walker Avenue. This connection will include a section of road proposed for private development in tandem with the last section being orchestrated by the City of Walker. Travelers should not see much impact on normal routes because this is largely off the road network. When completed, however, this will be a great improvement for the many employees that currently have only one exit from the North Ridge Drive corridor. This work is anticipated in the summer or fall of 2019.

One more enhancement on the horizon is the removal of the Walker Avenue bridge over the Coopersville/Marne Railroad. We recently received an economic development grant as part of a cooperative effort with Bissel to remove this bridge. The bridge is currently 2 lanes wide but it will be replaced with a 4 lane road with functioning turn lanes along Walker Avenue and at Waldorf Street. Utility relocation and preparation work is likely to begin this summer but the bridge removal will require extensive coordination and probably won't begin until 2020.

Public watermain is also being added along the west side of Maynard Avenue from O'Brien Road south to Millennium Park. Most of the work should be off the roadway but we are likely to see a short stretch of one lane road immediately adjacent to the construction activity. If you frequent this area be prepared for some minor delays with flag control or a temporary signal to protect the crews installing the watermain.

You may also see minor road and utility work occurring adjacent to numerous private developments. Delays may be necessary on Cummings Avenue, Lake Michigan Drive, Kenowa Avenue, Richmond Street, and many other locations around the city as we juggle the need to connect private sites with public roadways and utilities.

Thank you in advance for your patience as we continue to expand and maintain our public road system as well as promoting good development around the city. 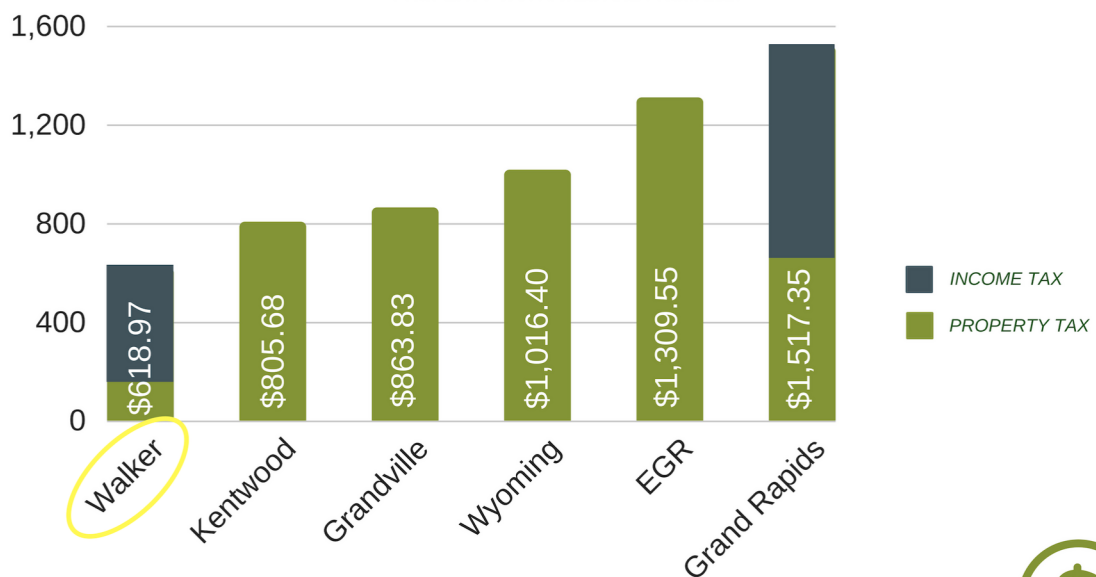

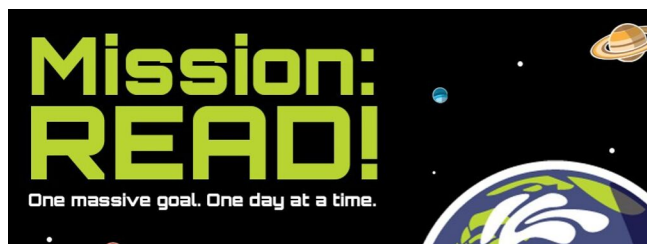

Here's how it works

Mission: Read helps beginning readers in kindergarten through third grade read at grade level and advance to fourth grade.

We're inviting young, beginning readers (kindergarten through third grade) to come with us on a trip that's out of this world! The mission is to read for 1,000 days before 6th grade. 1,000 days sounds like a lot—and it is—but Mission: Read makes it fun!

Readers will never be told what books to read and never have to set a timer. At the end of every day, they simply ask themselves, "Hey, did I read today?" If the answer is yes, they fill in a circle in their journal. Just like that, they'll be one day closer to the 1,000 day goal! They'll learn how easy it is to read every day and how it makes them a better reader. When reading becomes a daily habit, so many things become easier and more fun!

Follow these easy steps:

- Sign up at the public library.
- Receive a reading log and a solar system poster. For each day of reading, color in a circle on the reading log. Any reading during the day counts.
- After reading for 100 days, come to the library for a planet sticker. Make sure to come back every 100 days of reading to get another sticker—collect the entire solar system of planets.
- After 500 days, pick out a free book to keep.
- And finally, after 1,000 days, receive a tablet reader!
